The Undersigned athlete ("ATHLETE") on behalf of himself/herself and on behalf of the ATHLETE'S personal representatives, assigns, heirs, executors, hereby fully and forever releases, waives, discharges and covenants not to sue Orem City, Utah County, the RACE, USATF, Run13 LLC (and any affiliate of Run13 LLC), and any sponsor or cosponsor, including their officers, directors & employees, their subsidiaries and/or related companies or individuals related to the RACE from all liability to the ATHLETE and his/her personal representatives, assigns, heirs and executors, for all losses or damages and any and all claims or demands therefore, on account of injury to the ATHLETE or property or resulting in the death of the ATHLETE, whether caused by the active or passive negligence of all or any of the Releases or otherwise, in connection with the ATHLETE'S participation in the RACE. The ATHLETE is fully aware of the risks and hazards inherent in participating in the RACE and hereby elects to voluntarily compete in the RACE, knowing the risks associated with the RACE, including but not limited to, weather conditions such as high heat and/or humidity, traffic and the condition of the road, all such risks being known and understood by the ATHLETE. The ATHLETE hereby assumes all risks of losses, damages or injuries that may be sustained by him/her while participating in the RACE.
